## 1. Social Security in Mexico

- Mexican Institute of Social Security (IMSS). Private sector workers.
- Institute for Social Services and Security for State Workers (ISSSTE). Central and local government and public universities workers.
- Special systems for armed forces, PEMEX and IMSS workers

# 1. Social Security in Mexico

Common benefits of those institutions:

- Illnesses and maternity
- Nurseries for female workers' children
- Labor disability pensions
- Not labor disability, retirement, widowhood and orphanage pensions. State institutions cover local government workers
- Leisure (theaters and vacation centers) only the IMSS

# 2. Welfare Benefits

- Popular Security (*Seguro Popular*) is only for households outside of formal social security, covers only illnesses and maternity and is very cheap. It's free for twenty percent poorest household, and rise from 118 to 958 yearly dollars for sixty percent richest households.
- Opportunities (*Oportunidades*) is a fighting poverty program. It is focused to keep children and teenagers of the poorest households in the school given scholarships. Girl or boy loses the scholarship if she or he leaves the school. Girl's scholarship are bigger.
- The government of Mexico City gives assistance aid (65 monthly dollars) to people aged 70 and over. Central government is in process of enlarging this aid to the whole country.
- *Procampo* is a subsidy for peasants and small agricultural owners to buy seeds and fertilizers.

### 3. Data Sources

- Family Income and Expenditure Survey  
*(Encuesta Nacional de Ingreso y Gasto de los Hogares –ENIGH).*
  - Information concerning amount, distribution and the structure of household income and expenditure. It allows to generate information of the organization of current income (given the source), disposition of expenses according to the acquisition of final consumption goods (durables and non-durables), and capital and financial perceptions.
  - 23 174 households (94308 individuals).
  - Geographic Coverage: National.


### 3. Data Sources

- Frequency: Since 1992 every two years (2005 was extraordinary).
- Time Coverage: 1983-1984, 1989, 1992, 1994, 1996, 1998, **2000, 2002, 2004 y 2005.**
- We are working with 2004.
- Based on memories of 15 International Statistical Labour Conferences, International Labour Organization (ILO).
- Source: National Statistical Institute (*Instituto Nacional de Estadística Geografía e Informática –INEGI*).





