- The conference will be fully in person. Speakers will be requested to post papers and slides (narrated if possible) so that those who cannot join in person may have access.
- Participants not presenting papers are also welcome to join and should please register.
- Presentations on Day 1 of the conference (March 10) will focus on Thailand and the Asia-Pacific region, in the context of the global NTA research network.
- Days 2-4 (March 11-13) will consist of paper sessions, poster sessions, training workshops, and discussion sessions on topics of interest within the NTA network. If you have an idea for a workshop session, please contact the conference organizers to discuss.

  - 2. If you are planning on presenting a paper or poster, submit your abstract.

- The language of the conference will be English. There is a place to express preference for other presentation languages in the abstract submission form and if there are enough requests, we will add sessions in other languages.

### **Instructions for Submitting a Paper or Poster**

Go to the conference website at https://ntaccounts.org/s/Global15

First register for the conference by clicking on the "Registration" link. Then click on the "Submission of abstracts" link. Enter your information, with the "First Author" listed being the presenting author. This person must register for the conference. Abstracts are limited to 150 words with a maximum of 1,200 characters. Indicate whether this submission is to be considered for a paper session, a poster session, or either. Finally, select from the list of Theme Preferences, or if no theme is appropriate, write in a theme using the "Other" option.

When you submit your form, a copy will be sent to you using the email address you entered. You may edit your responses using a link in that email, up until January 1, 2025.

#### **Conference Motivation and Overview**

In the past year, the National Transfer Accounts network reached a major milestone: we now have estimates of the generational economy from 100 countries. What accounts for the consistent growth of interest in the NTA approach? It may be the growing realization that population change is one of the major forces reshaping our world right now. Fertility behavior is confounding predictions, with some countries experiencing sustained low-low fertility and population decline while others have sustained higher fertility when many forecasters predicted steady declines. In the face of this uncertainty about population, governments are looking for

high-quality research on how populations and economies impact each other and how to adapt to change while maintaining growth and societal well-being.

NTA is already providing actionable advice. Whether a country's population is young and growing, or aging and shrinking, the first step is generally to understand the generational and gendered economy by using NTA and National Time Transfer Account (NTTA) tools. Then, depending on whether the most pressing needs in the country are to ensure sustainability of social support systems, educate young people, grow the economy, or a host of other needs, NTA and NTTA tools can point the way towards policy responses to current and future challenges.

The 15th Global Meeting on Population and the Generational Economy will provide an opportunity for researchers and policy makers to present and discuss evidence on how population growth and changing age structures influence macroeconomic performance, gender and generational equity, public finances, and opportunities for meeting sustainable development goals, and what policies can help. The National Transfer Accounts (NTA) network welcomes participation from members of its country research teams and from those in government agencies, international organizations, public and private research institutions, media, and universities.

The first day of the conference will be targeted to a general audience of policy makers, media, researchers, students, and the public. Issues relevant to Thailand, Asia, and immediate neighbors will be highlighted. The subsequent days of paper presentations, workshops, training programs, and discussion groups will be targeted to members or prospective members of the NTA network but anyone interested in economic demography is welcome. Training workshops will be offered on days 2-4, including NTA basics and extended topics such as measuring the gendered economy using National Time Transfer Accounts.
