From 27 to 29 October 2021, the second edition of the NTA Africa Conference was held. It was organised by the Regional Consortium for Research in Generational Economics (CREG) in partnership with the Economic Commission for Africa's West Africa Sub-Regional Office, the United Nations Population Fund's West and Central Africa Regional Office (UNFPA/WCARO) and (ECA/BSR-AO).

This conference saw the participation of nearly 200 researchers and experts on Population and Development issues from some thirty countries and has permitted, through the various sessions and plenary sessions, to address issues that challenge the socio-economic and sustainable development of Africa.

In 2023, CREG, CEA/BSR-AO and Population Reference Bureau, in line with their commitment to support this agenda, have again joined hands to co-organise the third edition of this conference, which has become the space for dialogue between researchers and policymakers.

This edition will serve as a framework for reviewing all countries' achievements in terms of demographic dividend harnessing and taking stock five years after the adoption of the African Union's roadmap on this issue. A real lever for economic growth, the demographic dividend is defined as the economic growth that would result from the change in the age structure of the population.
